The Company received email/letter dated 26th June, 2023 from BSE regarding Non-compliance with respect to submission of secretarial compliance report within prescribed time period advising the Company to pay the respective applicable fine of Rs.18,880/- including GST to BSE.

The Company has submitted the pdf of Reg 24A on 18th May,2023 however on 31<sup>st</sup> May, 2023 we have received mail from BSE requesting to submit the report as per new format which the Company has submitted on 7th June, 2023. Consequently, the BSE has imposed a fine of Rs. 16,000, plus GST, totalling Rs. 18,880 for the 8 days delay in submitting the revised report.

As per the advice of the Bombay Stock Exchange vide Notice dated June 26, 2023, the above stated non-compliance of Regulation 24A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, which has been identified and indicated by the exchange and the details of the fine levied and paid by the company and subsequent actions taken thereof by the exchange in this regard has been placed before the board meeting held on 14th August, 2023.

The Board of Directors took a note of the same and advised that the same thing shall not be repeated again keeping in mind the reputation of the Company. This intimation is being given in compliance with the advice given by the exchanges vide notice as stated above.
